Sub: - Termination of Registration Certificate issued by DGS&D HQ and its regional offices.

The Union Cabinet chaired by the Prime Minister has approved, inter-alia, winding up of DGS&D and ceasing its functions by 31.10.2017. In order to wind up the DGS&D within the stipulated time frame, it has been decided to terminate all DGS&D Registration Certificates by 30.6.2017. All the firms which are engaged in supplying for goods/services to Government Ministries/Departments are advised to complete all transactions on or before 30.06.2017.


